is herewith certified that the receiver of the building works (recipient of services) is released from the duty to make tax deductions according to § 48 section 1 of the Income Tax Act.

This certificate shall be effective from **19th June 2007 until 18th June 2010.**

Important:

The original of this certificate must be handed over to the recipient of the services, if it is valid for specific building works. If the certificate is valid for a certain period of time, also a copy may be handed over. The original document carries a seal, a signature and a security number.

The recipient of services has the possibility to get sure about a possibly existing liability risk by examining the validity of the certificate of exemption. This examination can be made by an internet inquiry at the Federal Tax Agency (www.bzst.de). For this purpose, the data are stored at the Federal Tax Agency and are made known to the recipients of the services making the internet inquiry. If the Federal Tax Agency does not confirm the validity or the recipient of the services is not able to make the inquiry via internet, he may direct his inquiry to the local tax office given on the Certificate of Exemption to get sure. Failure to make an internet inquiry at the Federal Tax Agency or an inquiry at the local tax office **alone** does not give reason for gross negligence resulting in any liability.

The release from the duty to deduct taxes is effective for payments made within the above-mentioned period of validity and/or for the above-mentioned building works. The set-off (clearing) of a recipient of services with counterclaims as against the performing party is equivalent to a payment.

We reserve the right to withdraw this certificate.

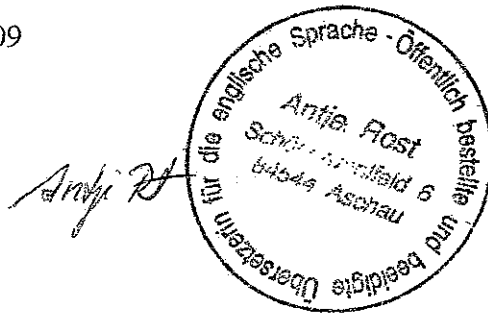
